


China 2030: Building a Modern, Harmonious, and Creative High-Income Society

The Global Entrepreneurship Monitor (GEM) project is an annual assessment of the entrepreneurial activity, aspirations and attitudes of individuals across a wide range of countries.

The Consequences of Inaction.

Humanity has witnessed unprecedented growth and prosperity in the past decades, with the size of the world economy more than tripling and population increasing by over 3 billion people since 1970. This growth, however, has been accompanied by environmental pollution and natural resource depletion. The current growth model and the mismanagement of natural assets could ultimately undermine human development. The OECD Environmental Outlook to 2050 asks "What will the next four decades bring?" With the strongest growth of any region in recent years, the East Asia and Pacific region now accounts for close to 20% of total global growth. However, growth varies across the region, and on average, it is slowing, with downside risks increasing as the global economic slowdown continues. After expanding 9.7% in 2010, GDP growth in East Asia slowed to 8.2% in 2011 and is projected to be 7.8% in 2012 and 2013.
